



## Rosedale Technical College and Fayette County Career and Technical Institute Articulation Agreement for College Credit Welding Program

### INTRODUCTION

Rosedale Technical College and Fayette County Career and Technical Institute agree to establish an articulation agreement for the purpose of eliminating the duplication of instruction for secondary students entering a post-secondary environment. This agreement is for the Welding Technician Program offered at Rosedale Technical College. This agreement is based upon:

1. Fayette County Career and Technical Institute curriculum adoption of the Competency Based Program of Study developed by the PA Department of Education.
2. The competencies identified by Fayette County Institute and Technical Center for the Welding Program and determined acceptable with the following Rosedale Tech course(s):

### ARTICULATION AGREEMENT REQUIREMENTS

Before articulated credits will be awarded the following conditions must be fulfilled by the prospective student prior to their start date:

1. Applicant must meet the standard admission criteria of Rosedale Technical College, to include a personal interview, successfully pass all program assessments, receipt of student's high school transcript, and provide proof of a valid driver's license.
2. The applicant must have achieved a grade of "B" or better in their program of study at Fayette County Career and Technical Institute.
3. The applicant must obtain a letter of recommendation from their Welding teacher.
4. The applicant must complete Rosedale Tech's admissions *Transfer Credit Form*, which is provided during the application process.
5. The applicant must start classes at Rosedale Tech within six (6) months upon graduating high school to be considered for articulated credits.
6. Upon completion of the Transfer Credit Form credits may be awarded, on a course by course basis, and the student will be granted credit(s) towards their tuition at Rosedale Technical College.
